Conditions of participation

Nomination

The most important criterion for the nomination is that the innovation contributes to greater efficiency in road freight transport. The transport company must achieve clear advantages for its daily work, for example: more safety, faster handling, less weight - and yet the product must bring economic advantages in the face of tough competition. The product must have significant technical improvements. Small improvements to details or facelifts are not enough.

Type of innovation

Innovations of all types and sizes (component, material, detailed solution, system solution, overall concept) from the trailer sector can be submitted until 28 June 2024. The submitted object must relate to the trailer, semi-trailer or body (not the motor vehicle). Prototypes and production-ready solutions that have been in series production for no longer than two years are eligible (deadline: 28 June 2024).

Conditions for award winners

If the participant is one of the winners, they must promise to present their object at the IAA Commercial Vehicles 2024 (if they do not have their own stand, at least on the day of the award ceremony as part of the event). A short film presentation of the object is desired for the award ceremony. Participation in the "Trailer Innovation" competition is not associated with participation fees or other costs.

Legal matters

There is no legal entitlement to an award. By participating, the participant accepts all rules and decisions of the jury.
